**Treasurer's Report:** Dwayne was absent

**Patrolman's Report:** Billy has been working on patching roads, working on the mower, cutting trees, talked about the mower blowing some oil. Reminder that he will be on vacation a few times in July.

**Clerk's Report:** Peat talked about the concrete project moving forward from the election audit- Bomkamp said that he would contact Brent Tisdale for a detailed cement bid, Bomkamp motioned/ Swaziek Second that we need to have written specs. Gardener Contract extension: Bomkamp motioned/Swaziek second that we extend our assessor contract with Gardener. She informed the board that the Avoca board sent out their report and it was available to look at. Swaziek said that there is a meeting with Avoca on July 18<sup>th</sup> about the future of Avoca Fire/EMS. Peat informed the board that Evers vetoed the grant for more transportation funds. She also informed the board that we have a random drug test to conduct.

**Chairman's Report:** Roy reported that the paperwork for the Septic system being pump has been completed. The fencing issues was brought up. Swaziek recommended a special meeting for Roy and Lisa to be able to collect more information and present professionally to the parties involved. Swaziek motioned to have a special meeting on July 21<sup>st</sup>/ Seifert second the motion. The meeting will be held at the Town Hall, starting at 7PM with a closed session, and hoping to reopen about 730PM

**Patrolman's Contract:** After receiving a copy of the contract, Billy Bahr has asked the board to have 7 days to look over the contract. A negotiation was asked to include Saturdays at overtime pay. The board motioned to pay Saturdays from December to March, or approved by the chairman in special weather situations. Swaziek would like the board to sign the new contract. Swaziek, Bahr, and Seifert signed the newly written contract. Swaziek has purchased a few of the basic PPE to be used by the patrolman. The board approved to order chaps, helmet, and glasses through George's Small Engines, Swaziek motioned/ Bomkamp Second

**Sign Request:** Bomkamp has contacted Elliot's about the existing School stop sign by their driveway. Elliot informed him that they purchased the sign and the township installed it. He is not willing to have his sign relocated. Seifert said that Jesse Hiltbrand was to reach out to us if he would like to have us order a sign. He has not had any contact with the board.
