**ATV ordinance:** Imhoff revised the preexisting ordinance to make sure that all of Town of Pulaski roads are open unless posted. Bomkamp motioned, Imhoff Second motion carried, Ordinance was signed and sent to Iowa County

**Patrolman Hiring:** Interview Committee recommended Dirk Drury to take over as the Road Patrolman of Town of Pulaski. Imhoff motioned, Bomkamp second, motion carried.

Drury talked about living in the township 10 years prior, been around farm equipment all of his life, was a truck driver, ran a small engine business, drove a school bus, had his own pulling tractor. He knows this job is a learning process but feels confident in learning the role
